1. Vehicle price determined from the purchase contract after subtracting any rebate, dealer discount, miscellaneous incentive as non-cash credit, or combination of the preceding. Any positive trade-in value or downpayment is not subtracted when vehicle price is determined, but is deducted when attaining the amount to be financed or due. Additional items that may be included on the purchase contract are applied to the formula as noted below.

2. Miles at the first warranted report OR miles at the first day out-of-service for the major portion of a day for a 30 days-out claim MINUS miles as of the date of purchase equals miles attributable to the consumer.

3. Purchase price X (miles attributable to consumer/100,000) = vehicle use allowance

4. Purchase price – use allowance = vehicle refund value.

$$\frac{\text{purchase price}}{\text{}} - \frac{\text{vehicle use allowance}}{\text{}} = \frac{\text{\$ vehicle refund value}}{\text{}}$$
