Low numbered registration plates are available for passenger cars, motor homes and light trucks (up to 6,099 lbs.) registered, or being registered, in Vermont at the pleasure car rate to Vermont residents. When the numbers are available, they are issued on a random basis. If you have received a low number within the past twelve (12) calendar months, you are not eligible for assignment of a low number.

A person who has a low number registration (101 – 9999) on a pleasure car or motor home may also have the same number on a light truck and vice versa, provided they are registered in the same name(s).

If this application is for a first time registration of a passenger car, motor home or light truck in your name, there is no extra fee. Please attach your completed Vermont Registration Application and associated paperwork and proper fees.

If the passenger car, motor home or light truck is currently assigned a regular set of passenger car or light truck plates, there will be a \$20.00 replacement plate fee due. Please enclose a Vermont Registration Application with Sections 2, 3A (for trucks), 4 and 8 completed along with the \$20.00 fee. If it is at renewal time, you must also enclose the \$65.00 renewal fee along with the \$20.00 replacement plate fee.

If the passenger car, motor home or light truck is currently assigned a special plate, (i.e. vanity, conservation, or Building Bright Futures plates), and the application is made at renewal time, you are required to pay only the renewal fee of \$65.00. Please enclose your renewal notice and the \$65.00 renewal fee.

If it is not renewal time for your "special" plate, you must pay the \$20.00 fee. Please enclose a Vermont Registration Application with Sections 2, 3A (for trucks), 4 and 8 completed along with your \$20.00 replacement plate fee.

I certify that I am a Vermont resident and have not received a low number within the past twelve (12) calendar months. I understand that if I am assigned a low number and do not renew the low number within sixty (60) days of the expiration of the registration, I lose all rights to the low number.
