The category "immediate family" is limited to the following: spouse, household member, mother, father, sister, brother, son, daughter, grandparent, grandchild and a party to a civil union.

A person who has a low number registration (101 – 9999) on a passenger car, motorcycle or light truck may also have the same number on a light truck, motorcycle and vice versa, provided they are registered in the same name(s).
