## GENERAL REGULATIONS GOVERNING THIS PERMIT

- 1. This permit applies to Well Drilling Rigs and Concrete Pump Trucks only. This permit shall be carried in the vehicle during authorized movement.
- 2. The use of this permit by the applicant signifies that s/he has read the terms of this permit and will comply with them.
- 3. Speed shall not exceed 45 miles per hour on State System for loads exceeding 90,000 lbs. or 10 feet in width, or over-height; on the Interstate, 60 miles per hour unless otherwise posted.
- 4. Travel with gross loads in excess of 108,000 lbs., or 10 feet 6 inches wide, or over 100 feet in length shall not be made on Saturdays, Sundays or the following holidays (Movement may be restricted before and after certain holidays and on Friday afternoons between July 1<sup>st</sup> and Labor Day):

• New Year's Day: January 1st

• Memorial Day: Last Monday in May

• Independence Day: July 4<sup>th</sup>

• Labor Day: 1st Monday in September

• Thanksgiving Day: 4th Thursday in November

• Christmas Day: December 25th

DAYLIGHT HOURS ONLY: Travel with vehicles and/or loads which are over-width or over-length or over-height shall be restricted to daylight hours and movement shall be made between 30 minutes before sunrise and 30 minutes after sunset. Vehicles which are overweight only, and are capable of traveling with the traffic flow, are not restricted to daylight travel time.

- 5. Over-length and over-width vehicles shall be equipped with red, Day-Glo or fluorescent orange FLAGS, at least 18 inches square, mounted on the four corners of all loads indicating the widest points.
- 6. No movement shall be made over highways or bridges posted for restricted loads in accordance with Sections 1551, 1552 of Title 19 VSA or Section 1398 of Title 23 VSA. Wooden bridges have special restrictions.
- 7. When overall width exceeds 8 feet 6 inches, and/or overall length exceeds 68 feet (except as provided in Section 1432(b)) prescribed sign reading "DANGER OVERSIZE" must be attached to the front and rear of the trailer.
- 8. When overall width is 12 feet or overall length is 80 feet, a pilot car is required, carrying prescribed sign and with flashing amber light. The pilot car will precede over-dimension load on State Highways and follow on Interstate Highways.
- 9. BLANKET PERMITS FOR STATE WIDE OPERATION: Maximum width 12-6 feet when length does not exceed 75 feet; maximum width 10 feet 6 inches when length is between 75 feet and 100 feet; maximum height 14 feet; maximum weight for indivisible loads is 108,000 lbs. Depending on the number of axles and axle spacing.
- 10. POSTED ROADS: During winter thaws, rainy periods, or when frost is coming out, the selectmen may post town roads and the District Transportation Administrators may post state highways. No load in excess of the posting is permitted, no permits can be issued, and blanket permits are suspended.
- 11. INCLEMENT WEATHER (for loads 12' wide or greater, and/or 80' long or greater): No travel is allowed during any ice condition, sleet, freezing rain, slush or combination thereof or any snow accumulation to the extent that it is heavy enough to stick to the highway surface; and no travel is allowed when visibility is reduced by rain, fog or any other weather condition to the extent that the load is not readily identifiable by users of the highway at a distance of a quarter (1/4) mile. At all times roads must be safe and clear enough to allow traffic to pass.
  - When such conditions exist during a trip, permitted vehicles must exit the road at the first available safe location where vehicle and load can park without impeding traffic until the weather conditions clear. A vehicle is not permitted to travel during inclement weather if it is subject to, or was required to have, an engineering review.
- 12. A permit is automatically invalidated by any violation of condition specified by the terms of the permit or by false information given on the application.
- 13. OPERATION AT 100' OR MORE IN LENGTH: The permit applicant shall file with the Commissioner of Motor Vehicles, a special certificate of insurance showing minimum coverage of \$250,000 for death or injury to one person, \$500,000 for death or injury to two or more persons and \$250,000 for property damage, all arising out of any one crash.
