Registration/Validation

The first registration or validation of a motorboat/personal watercraft/shuttlecraft (boat) in Vermont is subject to the sales tax unless:

- A purchase invoice shows a sales tax of 6% or more paid to a dealer in any of the 45 state jurisdictions imposing a sales tax. Alaska, Montana, Delaware, New Hampshire, and Oregon do not have a Sales and Use tax.
- The applicant is a nonresident of Vermont and purchased the boat in a state other than Vermont while a nonresident.
- The applicant is a nonresident of Vermont and purchased the boat in Vermont; however, they received title or possession or both in another state.
- The applicant is a nonresident of Vermont and submits a copy of a valid registration from his home state.
- The boat is acquired through a transfer to an individual (relative or not) for no consideration.

Registration

Titleable Boat

The boat is **new** (not previously registered anywhere):

- Original Manufacturer's Certificate of Origin.
 - o If the assignment made by other than Dealer, the title of one signing must be indicated or Power of Attorney Appointment submitted.
- Bill of Sale (for sales tax purposes)
- Additional Bill of Sale.
 - O All Bills of Sale must include the make, year, Hull Identification Number, purchase price, date and signature of Seller.

The boat is **used** and **has been titled** previously:

- The original (previous) Certificate of Title
 - O Must be signed by all parties listed as owners on the face of the title
 - o All liens must be released
 - O Death Certificates &/or probate letters when the owner(s) is/are deceased
- Bill of Sale
 - All Bills of Sale must include the make, year, Hull Identification Number, purchase price, date and signature of Seller.

The boat is **used** and **has not been titled** previously:

• Original or certified copy of last Registration Certificate and all Bills of Sale thereafter

Non-Titleable Boat

- A Bill of Sale (from Seller to you describing the boat by Hull Identification Number, make, year, date of sale, purchase price, and Seller's signature, or
- Seller's signature(in Section 5B of the Vermont Motorboat Registration Application (VD-037), or
- Copy of out-of-state Registration Certificate in your name

Motorboat Registration Number

DMV will assign the motorboat registration number. The owner shall either paint the number on each side of the motorboat's bow (front section) or purchase the numbers and attach them to each side. The registration numbers must be positioned and of a size to be clearly visible.

Vessel Validation

Validation is required for vessels registered in another state or documented by a federal agency (such as the U.S. Coast Guard or U.S. Bureau of Customs) used in Vermont waters for at least 60 days in any calendar year. This application must be accompanied by a copy of current registration or a valid document issued by the U.S. Coast Guard, the U.S. Bureau of Customs, or any other federal agency.

No Vermont registration or title is issued for Vessel validation, which expires annually at midnight on the last day of December.
