Only Vermont residents are allowed to obtain an Driver's License, Commercial Driver's License, Enhanced Driver's License/ID, Learner's Permit or Non-Driver Identification Card.

This affidavit may be used as proof of Vermont residency for applicants who are minors, or applicants who are over the age of 18 but reside with others. For proof of residency, the parent, legal guardian, homeowner, leaseholder, etc must complete this form and provide DMV with **one of the following documents** (with current name and street address; no PO Boxes):

- Utility bill (must list service address)
- Residential property tax bill (with physical location)
- [Vermont Tax Form LC-142](#) (Landlord Certificate)
- Vermont EBT or Vermont AIM identification card
- Homeowners/Renters insurance (policy/proof of claim)

US Military, Active Duty:

- If residing in Vermont see above
- If residing out of state; military ID and proof that Vermont is your residence in military records, such as Leave and Earnings Statement or orders

Proof of Residency Requirements for a Vermont License/Permit/ID

Vermont law requires an applicant for a Vermont License/Permit/ID to be a Vermont resident.

To prove Vermont residency, applicants must provide the Department with two pieces of mail with their current name and street address. These are not considered identity documents, they are only used to prove residency. If mail is not received at your street address, provide any two (2) of the following which show street address (not a PO Box):

- Utility bill -- must list service address
- Property tax bill with physical location
- [Vermont Tax Form LC-142](#) (Landlord Certificate)
- Vermont EBT (Electronic Benefit Transfer) card or Vermont AIM (Advanced Information Management) identification card
- Homeowners/Renters insurance (policy/proof of claim)

If the applicant resides with others and gets no mail at their street address:

- Complete Vermont Residency Certification (form TA-VL-02), and submit with one proof of residency document (above) from that person

US Military, Active Duty:

- If residing in Vermont see above
- If residing out-of-state; military ID and proof that Vermont is their residence in military records, such as Leave and Earnings Statement or orders

Minors:

- Parental Vermont Residency Certification (form TA-VL-02), one (1) parent residency document from above **and** acceptable proofs of relationship to applicant

This requirement pertains to new Licenses, Commercial Driver Licenses, Enhanced Driver Licenses or Non-Driver ID's, however, upon renewal of an applicant's Driver's License, Commercial Driver's License, Enhanced Driver's License or Non-Driver ID, if the applicant has an out-of-state mailing address, he or she is required to provide one of the above documents to prove Vermont residency. (An out-of-state mailing address is acceptable provided the applicant has a Vermont residential address.)

This does not affect visiting citizens of a foreign country. Any License or Non-Driver ID that may be issued to these applicants will expire coincidentally with their authorized duration of stay, provided that authorized stay has at least 30 days remaining.

Requirements for a Vermont Learner's Permit:

If two pieces of mail containing the applicant's current name and street address cannot be provided, the applicant must provide the Department with one of the documents indicated above along with a completed Vermont Residency Certification (form TA-VL-02). If the applicant is a minor, the parent/guardian will be required to provide one of the residency documents.

If the applicant is not a Vermont resident, he/she may only obtain a Vermont Learner's Permit for the purpose of participating in a driver education and training course. The applicant must provide the Department with one of the following:

- A letter from a school stating the student/applicant is to be enrolled in a driver education course, or
- A letter from a Driver Education School indicating the applicant/student is enrolled in a class.
