



<p>Real ID?</p>	<p>An EDL is a Real ID Compliant License that is also a border crossing document for US citizens returning home from Canada, Mexico, the Caribbean or Bermuda, by land or sea.</p> <p>Must be Vermont resident and US Citizen.</p>	<p>Real ID rules establish minimum standards, procedures, and requirements that Vermont must meet for Driver's License or ID cards to be accepted by the Federal government for official purposes.</p>	<p>A Driver Privilege Card is a Vermont license or permit that is NOT Real ID compliant.</p> <p>The Driver Privilege Card is available to anyone that is a Vermont Resident. Issuance of the DPC does not require proof of legal presence or US citizenship.</p>

<p>Board aircraft or access a federal facility</p>	<p>DHS has delayed enforcement of Real ID until October 1, 2021. After that date Federal agencies, including DHS and TSA, may only accept state-issued driver's licenses and identification cards as identification for purposes of accessing federal facilities - including TSA airport security checkpoints - if the license or card was issued by a REAL ID compliant state in accordance with the REAL ID security standards (meaning the license or card must include the REAL ID compliant star marking).</p>

Identity and date of birth	<p>Must provide one of the following:</p> <ul style="list-style-type: none"> • Valid, unexpired passport, • Certified record of the applicant's birth, marriage, adoption, or divorce, including a translation if necessary • Consular Report of Birth Abroad (CRBA) issued by the US Department of State (Form FS-240, DS-1350 or FS-545) • Valid consular identification document issued by the government of Mexico, Guatemala (or any other government with comparable security standards and protocols, as determined by the Commissioner) • Valid, unexpired Permanent Resident Card (Form I-551) • Certificate of Naturalization issued by DHS (Form N-550 or Form N-570) • Certificate of Citizenship (Form N-560 or Form N-561) issued by DHS • Driver's license/identification card (cannot be expired more than one year). 		
Social Security Information	<p>You must present your Social Security card or a letter from the Social Security Administration indicating ineligibility to receive a Social Security number (SSN).</p> <p>If your Social Security card is not available, one of the following forms may be used in its place: W-2 form, SSA-1099 form, pay stub showing name and SSN (minimum of last 4 digits) (Your name must verify with Social Security Administration). If there have been multiple changes to your name, you must provide documentation to prove the continuity of the names. For example: marriage or civil union certificate (certified copy issued by town/city), marriage or civil union dissolution or probate court name change document.)</p>		
Vermont residency and current residential address	<p>You must present two documents that include your name and current Vermont residential address that demonstrate residency in the state of Vermont. Examples include:</p> <ul style="list-style-type: none"> • piece of mail with current name and Vermont street address including city/town (no PO Boxes), • utility bill (must list service address), • property tax bill with physical location, • signed lease, • Homeowners/renters insurance (policy/proof of claim), • Vermont EBT or Vermont AIM identification card, • Vermont Residency Certification.
