




Real ID?	<p>An EDL is a Real ID Compliant License that is also a border crossing document for US citizens returning home from Canada, Mexico, the Caribbean or Bermuda, by land or sea.</p> <p>Must be Vermont resident and US Citizen.</p>	<p>Real ID rules establish minimum standards, procedures, and requirements that Vermont must meet for Driver's License or ID cards to be accepted by the Federal government for official purposes.</p>	<p>A Driver Privilege Card is a Vermont license or permit that is NOT Real ID compliant.</p> <p>The Driver Privilege Card is available to anyone that is a Vermont Resident. Issuance of the DPC does not require proof of legal presence or US citizenship.</p>

Board aircraft or access a federal facility	DHS has delayed enforcement of Real ID until October 1, 2021. After that date Federal agencies, including DHS and TSA, may only accept state-issued driver's licenses and identification cards as identification for purposes of accessing federal facilities - including TSA airport security checkpoints - if the license or card was issued by a REAL ID compliant state in accordance with the REAL ID security standards (meaning the license or card must include the REAL ID compliant star marking).

Identity and date of birth	<p>Must provide one of the following:</p> <ul style="list-style-type: none"> • Valid, unexpired passport, • A certified record of the applicant's birth, marriage, adoption, or divorce, including a translation if necessary • Consular Report of Birth Abroad (CRBA) issued by the U.S. Department of State (Form FS-240, DS-1350 or FS-545) • Valid consular identification document issued by the government of Mexico, Guatemala (or any other government with comparable security standards and protocols, as determined by the Commissioner) • Valid, unexpired Permanent Resident Card (Form I-551) • Certificate of Naturalization issued by DHS (Form N-550 or Form N-570) • Certificate of Citizenship (Form N-560 or Form N-561) issued by DHS • Real ID Driver's License or Identification Card issued in compliance with the standards established by 6 CFR part 37. 		
Social Security Information	<p>You must present your Social Security card or a letter from the Social Security Administration indicating ineligibility to receive a Social Security number (SSN).</p> <p>If your Social Security card is not available, one of the following forms may be used in its place: W-2 form, SSA-1099 form, pay stub showing name and SSN (minimum of last 4 digits) (Your name must verify with Social Security Administration). If there have been multiple changes to your name, you must provide documentation to prove the continuity of the names. For example: marriage or civil union certificate (certified copy issued by town/city), marriage or civil union dissolution or probate court name change document.)</p>		
Vermont residency and current residential address	<p>You must present two documents that include your name and current Vermont residential address that demonstrate residency in the state of Vermont. Examples include:</p> <ul style="list-style-type: none"> • piece of mail with current name and Vermont street address including city/town (no PO Boxes), • utility bill (must list service address), • property tax bill with physical location, • signed lease, • Homeowners/renters insurance (policy/proof of claim), • Vermont EBT or Vermont AIM identification card, • Vermont Residency Certification.

Lawful status in the United States	In most cases the documents required for proof of identity and date of birth will also establish lawful status in the United States. Term	Expires at midnight on the eve of the second or fourth birthday of the applicant following the date of issuance (2 or 4 years)	Expires at midnight on the eve of the second or fourth birthday of the applicant following the date of issuance (2 or 4 years) OR if marked as " Limited Term " Expiration date will coincide with the expiration of valid legal status obtained from documentation provided.
