Agent

- 14 VSA 3505(c) A person named as agent under the document may not serve as a witness or notary public with respect to the document.
- The agent does not have to sign at the same time as the principal, but the agent must sign before using the power of attorney for the first time.
- As an agent, Vermont Law imposes duties. Agents have what is known as a "fiduciary" duty to their principals. This means that an agent must act only for the principal's benefit.
- Below is a partial list of duties the agent <u>must</u> follow.
 - o Act in good faith.
 - o Refrain from doing things that benefit yourself rather than the principal.
 - o Avoid any conflicts of interest which impair your ability to act as your agent.
 - Stop acting as agent immediately if the principal revokes the power of attorney or if something else happens which terminates the power of attorney.
 - o Exercise the degree of care that would be observed by a "reasonably prudent person."

Vehicle Owner

- You must sign in the presence of a witness and a notary.
- The witness and the notary may not be the same person.
- The person named as the agent may not serve as the witness or notary.
- This power of attorney may be revoked by you at any time. You can revoke it in writing, by telling your agent, or by tearing it up or crossing it out, or any other act that shows you want it revoked. Tell your agent that you are revoking the power of attorney.

Witness

- 14 VSA 3505(c) A person named as agent under the document may not serve as a witness or notary public with respect to the document.
- As a witness, you declare that the principal appears to be of sound mind and free from duress at the time the Power of Attorney is signed. The vehicle owner has affirmed that he or she is aware of the nature of the document and is signing it freely and voluntarily.
